Board members are also "trustees" of Teresa House, who approve an annual budget that ensures the Comfort Care Home can meet its immediate and future financial needs.

Individual Board Members need to attend and actively participate at all board meetings, serve as officers and work diligently on sub-committees so that Teresa House can fully take advantage of all Board Members' talents and expertise. Board Members have, among their many duties, the responsibility to know and fulfill their proper role as a Board Member, acting only in the best interest of Teresa House and its residents at all times.

Board Members are expected to have a role as contributors to Teresa House.
